TAX LEVY ORDINANCE
AVON TOWNSHIP
ORDINANCE NO: 2016-12-12T

An ordinance levying taxes for all town purposes for Avon Township, Lake County, Illinois, for the tax year 2016, collectable in 2017.

BE IT ORDAINED by the Board of Trustees of Avon Township, Lake County, Illinois, as follows:

SECTION 1: That the sum of Seven hundred sixty five thousand nine hundred seventy three dollars (\$765,973.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with law, for such purposes as:

General Town Fund

General Assistance Fund

for the year 2016, collectable in 2017.

SECTION 2: That the amount levied for each object and purposes shall be as follows:


