

**TAX LEVY ORDINANCE
AVON TOWNSHIP
ORDINANCE NO: 2017-12-11T**

An ordinance levying taxes for all town purposes for Avon Township, Lake County, Illinois for the tax year 2017, collectible in 2018.

BE IT ORDAINED by the Board of Trustees of Avon Township, Lake County, Illinois as follows:

SECTION 1: That the sum of seven hundred and seventy six thousand, four hundred and thirty one dollars (\$776,431) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund
General Assistance Fund

for the 2017 tax year, collectible in 2018.

SECTION 2: That the amount levied for each object and purposes shall be as follows:

An ordinance levying taxes for all road purposes for Avon Township Road District Lake County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Avon Township, Lake County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Avon Township Road District on November 6, 2017 does hereby determine and declare that the sum of Nine Hundred Fifty Eight Thousand, Five Hundred and Thirty Three Dollars (958,533) upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with law, for such purposes as:
